

# ROLLO

## OF BANNOCKBURN

**SIR JOHN ROLLO OF BANNOCKBURN**, was second son of Andrew, 1<sup>st</sup> Lord Rollo, and was *b.* on 22 February 1602. He acquired the lands of Bannockburn from his brother-in-law, John Drummond of Carnock, on 18 June 1636, with remainder to himself and his heirs male born between he and Isabella Cockburn, his spouse.<sup>1</sup> He *d.* in March of 1666,<sup>2</sup> his nephew, Andrew, Lord Rollo, being served his heir male in the lands and barony of Bannockburn on 14 March 1672.<sup>3</sup> He *m.* firstly, to Isabella, daughter of Sir William Cockburn of Langton, (*c/m* 10 September 1635<sup>4</sup>), by whom he was father of :

1. Marion Rollo, *m.* firstly, to Mr. Robert Forrest, Minister at Kirkcaldy, (he *d.* in June of 1659 aged about 45 years), by whom she had issue. She *m.* secondly, to James Bruce of Garvell.
2. Helen Rollo, who was contracted to marry Robert Buchanan, 10<sup>th</sup> of Leny, in implementation of which she had a liferent of his lands on 15 June 1659, although he died the following month apparently before the wedding could take place. She *m.* on 10 November 1661, to James Pearson, 2<sup>nd</sup> of Kippenross,<sup>5</sup> (*c/m* 5 & 6 November 1661<sup>6</sup>), and had issue.
3. Anna Rollo, *m.* George Graham, 2<sup>nd</sup> of Monzie and Pitcairns, (*c/m* 12 December 1660<sup>7</sup>).

He secondly, to Annabel, daughter of Sir George Buchannan of that Ilk (*c/m* 5 April 1650<sup>1</sup>), and was father of,

4. Elizabeth Rollo, *bap.* at Saint Ninians on 15 June 1651.

5. Annabella Rollo, *bap.* at Saint Ninians on 5 February 1653 and *m.* at Edinburgh on 27 February 1677, to David Drummond, 3<sup>rd</sup> of Innermay.<sup>2</sup> She was buried in the Greyfriars, Edinburgh, on 6 February 1693,<sup>3</sup> having had issue.

6. Jean Rollo, *bap.* at Saint Ninians on 8 November 1661, *m.* in 1678, to Sir Alexander Innes of Cockston, (he survived her and *m.* secondly, to Jean, daughter of Patrick Meldrum of Leathers ; and *d.* on 28 January 1709), and had issue.

He *m.* thirdly, Helen, daughter of Sir William Sinclair of Roslin (*c/m* 27 August 1664. She survived him and *m.* secondly by *c/m* 13 February 1672,<sup>4</sup> to William Stirling, 2<sup>nd</sup> of Herbertshire), and was father of :

7. Isabella Rollo, *bap.* at Saint Ninians on 17 January 1666 and *d.* unmarried prior to 8 May 1683, when her Testament was proved.<sup>5</sup>
