James, Duke of Chattellarault, Earl of Arran, Lord Hamilton, and Jane Hamilton, his lawful daughter, on the one part, and Hew Montgomery, Earl of Eglinton, with consent of Dame Marion Seton, Countess of Eglinton, Robert, Lord Sempill, Richard Maitland of Lethington and Hew Wallace of Carnell, his curators, on the other part, for the marriage of the said Jane and Hew Montgomery. Dated 13 February 1554.

Contract of marriage between Walter Bruson of Pitcullen taking burden on Isabel, his daughter, on the one part, and Patrick Bruson, servant to Patrick, Lord Ruthven, on the other part, for the marriage of Isabel and Patrick. Dated 8 January 1554.

## RD1/3/250b

Contract of marriage between David Ogilvy of that Ilk and Gilbert, his eldest son and heir, on the one part, and Sir John Campbell of Lundy and John, his eldest son and heir, on the other part, for the marriage of the said John Campbell and Barbara Ogilvy, daughter to the said David. Dated 1554.

Discharge by David Lindsay of Vane, son and heir of the deceased Alexander Lindsay of Vane, to Alison Charteris, relict of the said Alexander. Dated 14 December 1584.
