of BANNOCKBURN

HUGH PATERSON,¹ was second son of James Paterson, portioner of Letham, and settled on the lands of Frew, near Stirling. He *m.* Margaret Dog, said to be a daughter of Dog of Ballingrew, and *d.* in 1666 having had issue,

1. Sir Hugh Paterson of Bannockburn, (*see below*).
2. Robert Paterson, who is named with his parents in 1665.

SIR HUGH PATERSON, 1ST BARONET OF BANNOCKBURN, was apprenticed to Richard Guthrie, W.S. and admitted a member of the Society of Writers to the Signet on 10 April 1661. He acquired the lands and barony of Bannockburn in 1672 and held a number of appointments including as a Commissioner of Supply for Stirlingshire in 1678 and 1685, and Keeper of the Signet on 28 September 1682, and was created a Baronet 29 March 1686, with remainder to the heirs male of his own body.

He *m.* at Edinburgh, on 18 August 1654, to Elizabeth, daughter of Sir Thomas Kerr of Fernyhurst,² and *d.* in 1696. He was father of :

1. Andrew Paterson, *bap.* at Edinburgh, on 13 April 1654 and *d.* young.
2. Sir Hugh Paterson, 2nd Baronet of Bannockburn, (*see below*).
3. Agnes Paterson, *bap.* on 18 May 1655.
4. Margaret Paterson, *bap.* at Edinburgh, on 10 October 1656.
5. Elizabeth Paterson, *bap.* at Edinburgh, on 9 March 1660.

SIR HUGH PATERSON, 2ND BARONET OF BANNOCKBURN, *bap.* at Edinburgh, on 4 February 1662 and succeeding his father, he was served heir to him in the lands and barony of Bannockburn on 9 November 1696.¹

He *m.* Barbara, daughter of Sir William Ruthven of Dunglas, and *d.* in December 1701² having had issue,

1. Sir Hugh Paterson, 3rd Baronet of Bannockburn, (*see below*).
2. James Paterson, *bap.* at St. Ninians, on 8 July 1689 and *d.* in infancy.
3. Sir James Paterson, *b.* on 7 August 1692 and served as a Lieutenant-General in the army of the King of Sardinia and Governor of Nice. He *d.* at Bath, on Thursday 5 September 1765 and was interred in the family vault at St. Ninians.³
4. William Paterson, was admitted to the Society of Writers to the Signet on 8 March 1714 and *dsp* in 1716.⁴
5. Robert Paterson, was admitted to Burgess of Edinburgh on 21 January 1713.⁵
6. Alexander Paterson, *bap.* at St. Ninians, on 6 April 1694.
7. Elizabeth Paterson, *m.* on 18 May 1695, to Charles Smith, Merchant,⁶ and had issue.
8. Mary Paterson, *b.* on 3 April 1691 and *d.* unmarried, in 1716.⁷
9. Barbara Paterson, *bap.* at St. Ninians, on 17 July 1695.
10. Katherine Paterson, *m.* John Walkinshaw of Barrowfield, and *d.* at Edinburgh, on Saturday 25 November 1780, aged 97,⁸ leaving issue.

SIR HUGH PATERSON, 3RD BARONET OF BANNOCKBURN, *bap.* at St Ninians, on 10 February 1686 and was served heir to his father on 1 September 1702.¹ He served as Member of Parliament for Stirlingshire from 1708 until being unseated in 1709, then served again from 1710-15, and was a Commissioner of Trade in Scotland but was attainted for involvement in the Jacobite uprising of 1715, for which he was pardoned in 1726.²

He *m.* at Twickenham, on 21 February 1712, to Jean, daughter of Charles Erskine, 10th Earl of Mar,³ (she *d.* at Bannockburn, on 16 November 1763), *d.* at Touch, on 23 March 1777, when the Baronecty extinguished, and was father of,

1. Hugh Paterson, younger of Bannockburn, *m.* on Thursday 18 November 1742, to Elizabeth, daughter and heiress of Archibald Seton of Touch,⁴ and assumed the surname and arms of Seton of Touch, (post-nuptial *c/m* 24 March 1743. She survived him and *m.* secondly, at Linlithgow, on 21 September 1745, to her cousin, Hugh Smith, by whom she had issue ; and *d.* at Touch, on 3 February 1775). He *dsp* of a “high fever,” on Friday 23 September 1743.⁵
2. Mary Paterson, (*see below*).

MARY PATERSON, *bap.* on 25 April 1714 and was served heir of provision to her brother, Hugh, on 17 December 1743.⁶ She *m.* on 22 November 1750, to David Rollo of Powis,⁷ who assumed the surname and arms of Paterson of Bannockburn, (he *d.* at Bannockburn House, 10 March 1786⁸), and had issue :

1. Hugh James Paterson Rollo of Bannockburn, (*see below*).

2. Davida Paterson Rollo, *m.* at Bannockburn House, on 4 October 1777, to Alexander Wallace, Banker in Edinburgh,¹ and had issue.
3. Mary Erskine Paterson Rollo, *m.* at Bannockburn House, on 10 February 1777, to George Home Stewart, 4th of Ballachallan and Argaty,² (he survived her and *m.* secondly, on 20 November 1785, to Jane, daughter of John Munro of Binning, by whom he had further issue), and *d.* at Bannockburn House, on Tuesday 7 July 1778,³ having had issue.
4. Margaret Paterson Rollo, *bap.* on 18 January 1753.

HUGH JAMES PATERSON ROLLO OF BANNOCKBURN, *bap.* on 17 September 1751 and succeeded to his maternal lands of Bannockburn. He *m.* on 11 December 1777, to Helen, only daughter of Robert Arbuthnott,⁴ (she *d.* on 5 February 1838⁵), and had issue,

1. David Rollo, *b.* at Bannockburn House, on 4 January 1780 and *d.* young.
2. Michael Rollo, *bap.* at Saint Ninians, on 13 May 1781 and *d.* young.
3. Hugh James Rollo of Bannockburn, (*see below*).
4. Elizabeth Rollo, *bap.* at Saint Ninians, on 6 October, 1778.
5. Charlotte Rollo, *bap.* at Saint Ninians, on 6 December 1787 and *m.* on 31 July 1809, to Henry Moncrieff, W.S.,⁶ third son of Sir Henry Moncrieff Wellwood, Baronet of Tulliebole, (he *d.* on 16 April 1817).

HUGH JAMES ROLLO OF BANNOCKBURN, *bap.* at Saint Ninians, on 4 February 1783 and was admitted to the Society of Writers to the Signet on 10 March 1806. He *m.* on 12 July 1813, to Jane Hathorn, eldest daughter of William Richardson

of Keithock,¹ (she survived him and *d.* at India Street, Edinburgh, on 27 August 1849²), and was drowned on board the steamer *Comet II*. when it collided with the *Ayr* off Gourock on 21 October 1825.³ He was father of,

1. Hugh James Rollo of Bannockburn, (*see below*).
2. William Richardson Rollo, *b.* on 26 February 1824 and *m.* at St. John's Chapel, Edinburgh, on 18 November 1846, to William Gairdner Jolly, Catter, Dumbartonshire.⁴
3. Helen Arbuthnot Rollo, *d.* unmarried, at India Street, Edinburgh, on 20 August 1849.⁵
4. Jane Hathorn Rollo, *d.* unmarried, at Dundas Street, Edinburgh, on 29 January 1855.⁶
5. Mary Francis Rollo, *b.* on 10 December 1819 and *d.* unmarried, at Dundas Street, Edinburgh, on 10 June 1856.⁷
6. Agnes Rollo, *b.* on 24 April 1822 and *d.* unmarried, at Edinburgh, on 29 August 1846.⁸
7. Erskine Rollo, *b.* on 3 May 1826 and *d.* unmarried, at Torphicen Street, Edinburgh, on 27 May 1887.⁹

HUGH JAMES ROLLO OF BANNOCKBURN, *b.* on 16 June 1818 and was trained in the office of his uncle, John Richardson, W.S., following which he was a Writer to the Signet on 20 May 1847.

He *m.* firstly, at Aberdeen, on 30 November 1865, to Mary, only daughter of Alexander Stuart of Inchbreck,¹ (she was *b.* on 9 July 1834 and *dsp* on 20 July

1875), and, secondly, at the parish church, Middleton Tyas, Yorkshire, on 15 January 1880, to Mary, eldest daughter of the Rev. John Hutton Pollexfen of Cairston, Orkney, and Vicar of Middleton,² and *dsp* at Randolph Cliff, Edinburgh, on 28 February 1890.³
