STEWART of GRANDTULLY

ALEXANDER STEWART, 1ST OF GRANDTULLY, was younger son of Sir John Stewart of Innermeath and Lorn, and was shield-bearer to Archibald, Earl of Douglas, from whom he had a charter for the lands of Grandtully, Kyltullych and Aberfeldy, all in the Abthainery of Dull and sheriffdom of Perth, on 30 March 1414, with remainder to himself and the heirs male of his own body, which failing, to his father, Sir John Stewart, Lord of Lorn, and his heirs male. He also acquired the lands of Carnbo, in Strathearn, from Christiana de Mure, Lady of Brintscheils by charter of 1 June 1419.²

He m. Margaret, daughter of John Hay of Tulliebody, with whom he had a charter for the lands of Banchry from her brother, John Hay of Tulliebody, in contemplation of their marriage on 15 July 1416³ and d. before 10 July 1449. He was father of :

THOMAS STEWART, 2ND OF GRANDTULLY, had succeeded his father by 19 July 1449 when he entered into an agreement with William, Abbot of Coupar Angus, concerning the marches of the lands of Murthly,⁴ and had a grant of part of the lands of Comrie in 1452. He was included in the remainder of an entail for in the Lordship of Lorn in the same year⁵ and *d.* in 1453/54 having had issue;

ALEXANDER STEWART, 3RD OF GRANDTULLY, succeeded on his father's death in 1453 but being under age, his lands fell to the crown and his ward was gifted by the king to John Stewart of Fortingal.⁶ His lands remained in ward in 1460⁷ and he appears to have attained his majority by 13 May 1462 when on that date, he was served heir to his father in the lands of Grandtully on 13 May 1462.⁸ He also had service as heir to him in those of Banchrie on 2 June following.⁹

He *m.* by 16 May 1466, to Matilda, daughter of Sir James Stewart, son of Murdoch Stewart, 2nd Duke of Albany, when they had a charter of confirmation, on his own resignation, for the lands of Kiltuly and Aberfeldy,¹⁰ and whose liferent was confirmed to her in their son, John's charter for the lands of Aberfeldy &c., dated 5 July 1470.¹¹ He *d.* before March 1488 and was father of,

- 1. John Stewart, fiar of Grandtully, to whom his father conveyed the lands of Grandtully, Aberfeldy, and others by instrument dated 5 July 1470.¹² He *dsp vita patris*.
- 2. **THOMAS STEWART, 4TH OF GRANDTULLY,** who, succeeding his father, was infeft in the lands of Banchry by Sasine of 13 March 1488.¹³ He *m*. in 1481, to Agnes, daughter of Sir William Moray, 8th of Tullibardine, (who survived him and is named in an action by his brother, Alexander, for wrongful occupation of the lands of Pitcairn on 23 March 1500/01¹⁴), with whom he had a conjuct charter for his lands of Grandtully on 2 July 1494.¹⁵ He *d*. after then and before 22 August following having had issue,
 - 1a} Elizabeth Stewart of Grandtully, succeeded her father and in defiance of the remainder being to the heirs-male, with the "expresso consensu et assensur Agneti Murray, domine liberi tenementi de Garnetully," she was infeft in the lands of Grandtully on 12 January 1494. She was also infeft in those of Carnb-Stewart by Sasine of 22 April 1516. She m. Archibald Campbell of Skipnish with whom she resigned the lands of Grandtully to her uncle and heirmale, Alexander Stewart, on 15 March 1525 and disponed her remaining lands of Carnbo-Stewart to her cousin and heir, Thomas Stewart, fiar of Grantully, by charter dated 4 June 1532.

4. Elizabeth Stewart, m. Neil Stewart of Garth, and had issue.

ALEXANDER STEWART, 5TH OF GRANDTULLY, succeeded as heir male to his brother, Thomas, but he long contested his rights with his niece, Elizabeth Stewart, and her husband, Archibald Campbell of Skipnish. Following his elder brother's death, on 22 August 1494 he raised an interruption to have a Sasine for the lands of Grandtully cancelled,²⁰ then on 2 October following, he protested that Neil Stewart of Fortingal had refused to carry out a mandate from the king to grant him Sasine for the lands of Grandtully as heir of tailzie to his late brother Thomas.²¹ After a period of almost three decades, he eventually received resignations to him by that niece of Grandtully, Aberfeldy &c., on 15 March 1525, in which he was infeft by Sasine of 5 July following,²² and which were confirmed to him by the King in a charter expede under the Great Seal on 28 April 1526.²³

He m. Margaret, apparently daughter of Michael Murray, 1st of Coig, (Dispensation dated 23 June 1507²⁴), and d. about 1540, having had issue;

- 1. Sir Thomas Stewart, 6th of Grandtully, (see below).
- 2. Elizabeth Stewart, m. John Stewart, 1st of Dalguise, (he d. in 1576), and had issue.

SIR THOMAS STEWART, 6TH OF GRANDTULLY, in favour of whom his cousin, Elizabeth Stewart of Grantully, made a resingation of the lands of Carnbo-Stewart on 4 June 1532²⁵ and on 1 March 1538, he received those of Grandtully from his father by resignation of that date,²⁶ which were confirmed to him by charter under the Great Seal on 14th following.²⁷ He *m*. Margaret, daughter of Sir William Moray of Castleton, with whom he had a conjuct charter for the lands of Petocharne and Tullochcorce, in the barony of Grandtully, on 11 December 1540,²⁸ and was father of,

- 2. Alexander Stewart, 1st of Carse, acquired the lands of Carse, Carsemuly and Petwasse, on 20 January 1566 and is then styled brother to William Stewart of Grandtully. He *m*. firstly, by 13 March 1562, to Isabel Gourlay,²⁹ and surviving her, he *m*. secondly, to Jean, daughter of Maurice Drummond of Auchtermuthill, (she was widow of William Pitcairn of Pitlour, by whom she had issue), to whom he granted a liferent of his lands of Carse on 17 July 1584.³⁰ He *d*. before 26 January 1600, and was father of,
 - 2a} John Stewart, 2nd of Carse, who, with Elizabeth, sister of Alexander Blair of Balgray, his future wife, had a conjunct charter from his father for the lands Carse on 22 January 1594.³¹ He *dsp* before July of 1609.
 - 2b) Margaret Stewart, m. John Stewart, 4th of Bonskeid, (c/m 11 October, 1572), and had issue.
- 3. John Stewart, 1st of Findynate, had Sasine for the lands of Easter and Wester Findoynet and the Easter and Wester parts of the lands of Tulliepowries from John Stewart, Earl of Atholl, on 7 August 1575,³² and had issue, *(see Stewart of Findoynet)*.
- 4. Janet Stewart, *m*. George Robertson, 2nd of Faskally, (he survived her and *m*. secondly, to Christine, daughter of George Oliphant of Ardchalzie, who *m*. again after his death, to John Robertson, 1st of Monzie. George *d*. by 30 December 1567, when his eldest son, Alexander Robertson, reserved a liferent of certain lands to his step-mother, Christine Oliphant), and had a charter from her husband for the liferent of the lands of Calvine, Pitgowan, and others, on 29 March 1557, in which she is styled daughter to Thomas Stewart of Grandtully.³³ They had issue.

WILLIAM STEWART, 7TH OF GRANDTULLY, succeeded his father and m. firstly, to Margaret, daughter of Alexander Abercromby of Murthly, with whom, on his father's resignation, he had a conjunct charter under the Great Seal for the lands of Aberfeldy on 2 January 1545.³⁴ He m. secondly, by 22 April 1552, to Elizabeth, daughter of John Stewart, 3rd Earl of Atholl, when they had a charter of the lands of Aberfeldy,³⁵ and d. at Grandtully, on 4 March 1574.³⁶ He was father of:

- 1. **SIR THOMAS STEWART, 8TH OF GRANDTULLY,** succeeded his father in 1574, and was served heir to him on 14 May 1575.³⁷ He *m*. Grizel, daughter of Sir Laurence Mercer of Meikleour, (she survived him and *m*. secondly, by 1619, to James Ogilvy of Clova), to whom, in her virginity, he granted a charter for his lands of Duoreskin and Cultully on 21 March 1569, in which she is styled his future wife. He *d*. between 13 June 1610 and 28 December 1611, and was father of:
 - 1a} John Stewart, younger of Grandtully, who witnessed a charter by his father for the lands of Banchrie in favour of William Stewart, his brother, on 22 October 1595 in which he is styled his apparent heir.³⁸ He *dsp vita patris*, before 30 December 1603, when his uncle William Stewart is styled heir apparent to Grandtully.
- 2. Sir William Stewart, 9th of Grandtully, (see below).
- 3. Margaret Stewart, *m*. George Stewart, 5th of Arntully and Cardney, (*c/m* 29 April 1566. He survived her and *m*. secondly, by 20 May 1588, to Janet, daughter of Alexander Robertson, 1st of Faskally, who was then widow of John Stewart, 1st of Findynate), and had issue.
- 4. Grizel Stewart, whose hand was offered in marriage to Peter Scott, younger of Monzie.³⁹ She *d.* unmarried, in November 1579.

He was also father of a natural son:

 William Stewart, in whose favour a precept for letters of legitimation passed the Privy Seal on 10 May 1584.⁴⁰

SIR WILLIAM STEWART, 9TH OF GRANDTULLY, had a charter for the lands of Banchrie, in the barony of Tulliebody, from his brother, Sir Thomas Stewart, on 22 October 1595 in which he is styled one of the gentlemen of the King's chamber,⁴¹ and had a further charter from that brother for the lands and barony of Grandtully by charter dated 4 July 1609.⁴²

He m. Agnes, eldest daughter of Sir John Moncrieff of Easter Moncrieff, (c/m at Perth, on 30 August 1605⁴³), and d. in 1646, having had issue,

- 1. **THOMAS STEWART, 10**TH **OF GRANDTULLY,** to whom his father conveyed the lands and barony of Grandtully on 27 February 1623,⁴⁴ and had a charter under the Great Seal for the lands and barony of Strathbraan on 31 July 1638. He *m.* Grizel, second daughter of Sir Alexander Menzies of Weem, (*c/m* 25 May 1627 & 8 February 1628⁴⁵), with whom he had a conjunct charter under the Great Seal for the lands and barony of Carcock in which she is styled second daughter of Sir Alexander Menzies of Weem, and *d.* on 10 August 1688.⁴⁶ He was father of:
 - 1a) **JOHN STEWART, 11TH OF GRANDTULLY,** succeeded his father in 1688 and executed an extensive entail of the family estates on 31 March 1717. He *d.* unmarried, at Dundee, in February of 1720.
 - 1a} Jean Stewart, *m*. Sir James Mercer of Meikleour and Aldie, (*c/m* 1 February 1648.⁴⁷ He *d*. at London, on 19 February 1671), and had issue.
 - 1a} Marjory Stewart, *m*. David Fotheringham of Powrie, (*c/m* 20 November 1656.⁴⁸ He survived her and *m*. secondly, to Rachel, daughter of David Aytoun of Kinnaldie, who was then widow of James Alexander of Finglassie), and *d*. by May of 1696. They had issue whom in 1900, succeeded to the Grandtully estate as eventual heirs of entail, (*see Fothringham of Powrie*).
 - 1a} Grisel Stewart, m. Sir John Drummond, 1st of Logiealmond, (c/m 18 August 1664⁴⁹), and had issue.
 - 1a} Anne Stewart, *m*. James Seaton of Touch, (*c/m* 20 April 1664.⁵⁰ He was widow of Elizabeth, daughter of Henry Maule, Keeper of the Signet, and following Anne Stewart's death in 1668, he *m*. thirdly, to Elizabeth, daughter of Sir Archibald Stirling of Keir, by whom he had issue), and *d*. without surviving issue in December of 1668.

- 2a} Cecil Stewart, *m*. John Stewart, 8th of Arntully and Cardney, (he survived her and *m*. secondly, Agnes, daughter of Patrick Rattray, 18th of Craighall, by whom he had issue), and had no apparent issue.
- 2a} Helen Stewart, m. James Crichton, 9th of Ruthven, (c/m 20 May 1669⁵¹), and had issue.
- 2a} Elizabeth Stewart, *m.* on 26 May 1670, to David Leslie, 2nd Lord Newark,⁵² (he *d.* on 15 May 1694), and was buried at Holyrood, 17 January 1714.⁵³ They had issue.
- 2. Sir William Stewart, 1st of Innernytie, was a substitute heir to his elder brother Thomas in the lands of Grandtully on 27 February 1623 and is then styled the second son. He *m*. by 5 July 1643, to Mary, daughter and coheiress of Sir John Crichton of Innernytie and Airliewright, and had issue, *(see Stewart of Innernyte)*.
- 3. James Stewart, was also a substitute heir to his elder brother Thomas in the lands of Grandtully on 27 February 1623, and is then styled third. There is no further evidence to prove that he married or left issue and he is generally considered to have *dsp*.
- 4. **HENRY STEWART**, was a substitute heir to his elder brother Thomas in the lands of Grandtully on 27 February 1623 and is then styled fourth son. He had issue which carried on the line of succession, (see below).
- 5. John Stewart, 1st of Fungorth, was a substitute heir to his elder brother Thomas Stewart in the lands of Grandtully on 27 February 1623 and is then styled the youngest son. He acquired the lands of Fungorth and *m*. Isobel, daughter of James Stewart, 1st of Ladywell, (*c/m* 11 September 1638.⁵⁴ She survived him and *m*. secondly, on 14 January 1655, to John Blair of Ardblair, ⁵⁵ by whom she had further issue). He *d*. by 1655 and had issue, (*see Stewart of Fungorth*).
- 6. Grizel Stewart, d. in 1613 and was buried in the Chapel at Moncrieff.

HENRY STEWART, was a substitute heir to his elder brother Thomas in the lands of Grandtully on 27 February 1623, and is then styled fourth son of Sir William Stewart [10th] of Grandtully. He *m*. Mary, daughter of Sir Colin Campbell, 3rd of Aberuchill, and *d*. in November of 1680,⁵⁶ having had issue,

- 1. Sir Thomas Stewart, 1st Baronet, of Blair, (see below).
- 2. James Stewart, is styled second son in his father's Testament and was apprenticed to Thomas Kincaid, Apothecary in Edinburgh, on 16 December 1658.⁵⁷ He became a physician in Edinburgh and *m*. there, on 26 July 1678, to Mary, daughter of his Master, Thomas Kincaird, Apothecary in Edinburgh.⁵⁸ He was father of:
 - 2a} Thomas Stewart, bap. at Edinburgh, on 12 September 1681.
 - 2a} Elizabeth Stewart, *bap*. at Edinburgh, on 10 September 1680 and *m*. Colonel Thomas Hamilton, of the Scots Regiment of Foot Guards, (*c/m* 28 April 1703⁵⁹). They had issue.
- 3. Marjory Stewart, *m*. William Borthwick, 1st of Pilmuir, son and heir of Alexander Borthwick, in Johnstonburn, second son of William Borthwick of Soltray, and had issue.
- 4. Elizabeth Stewart, *m.* on 24 September 1656, to James Drummond, 1st of Cultmalundy,⁶⁰ and had issue.
- 5. Helen Stewart, *m*. firstly, to Dr. David Carnegie, son of Charles Carnegie, Dean of Brechin, younger son of Sir Alexander Carnegie of Pittarow, and is styled daughter of Henry Stewart, brother to Sir Thomas Stewart of Grandtully, in a Bond of 1668. Survivig that husband, she *m*. secondly, to George Moncrieff of Readie.⁶¹

SIR THOMAS STEWART, 1ST **BARONET, OF BLAIR,** who, as nearest agante, was appointed tutor-at-law to John, William and Anna, children to the deceased John Stewart, 1st of Innernytie, on 19 February 1681. He was created a Baronet on 2 June 1683, with remainder to himself and the heirs male of his body, and was admitted an Ordinary Lord of Session in place of Sir David Nevay, on 7 November 1683. He afterwards succeeded Lord Hardcarse as a Lord of Justiciary on 28 July 1688, although he was deprived of that office at the Revolution in 1690.

He m. Jean, daughter of George MacKenzie, 1st Earl of Cromarty, and was father of:

- 1. Thomas Stewart, b. in July of 1685 and d. young.
- 2. **SIR GEORGE STEWART, 12TH OF GRANDTULLY,** *b.* on 12 October 1686 and succeeding his cousin, John Stewart, 13th of Grandtully, in the lands of Grandtully, he was served heir to him on 25 January

1721.⁶² He *m*. Anne, daughter of Sir Archibald Cockburn of Langton, (she *d*. at Dundee, on 20 August 1757), and *dsp* at Edinburgh, on 3 November 1759,⁶³ when he succeeded by his brother, John.

- 3. Sir John Stewart, 13th of Grandtully, (see below).
- 4. Kenneth Stewart, *d.* unmarried, before 20 January 1721 when his brother, John, was served heir to him.⁶⁴
- 5. Margaret Stewart, b. in July of 1685.

SIR JOHN STEWART, 13TH OF GRANDTULLY, *b.* on 29 September 1687 and was served heir to his brother, Kenneth, on 20 January 1721.⁶⁵ He also succeeded his brother, Sir George Stewart, and his cousin, Sir John Stewart, in the lands of Grandtully and was served heir to both of them on 20 May 1760.⁶⁶

He *d.* at Murthly, on Thursday 14 June 1764,⁶⁷ having *m.* firstly, on 13 January 1725, to Elizabeth, daughter of Sir James MacKenzie, Lord Royston, by whom he was father of:

- 1. George Stewart, who *d.* young.
- 2. Sir John Stewart, 14th of Grandfully, (see below).

He m. secondly, privately, at her house near Edinburgh, on 4 August 1746, to Jane, only sister of Archibald, Duke of Douglas, ⁶⁸ (she was b. at Douglas, on 17 March 1698 and d. at Edinburgh, on 22 November 1753⁶⁹), and by her he had further issue :

- 3. Archibald Stewart, 1st Lord Douglas of Castle Douglas, *b*. at Aix-la-Chapelle, on 10 July 1748 and was served heir to his uncle, Archibald, Duke of Douglas, on 10 September 1761,⁷⁰ then created Lord Douglas of Douglas Castle on 9 July 1790. He *m*. firstly, at London, on Tuesday 13 June 1771,⁷¹ to Lucy, daughter of William Graham, 2nd Marquis of Montrose, (*c/m* 12 June 1771.⁷² She was *b*. in July of 1751 and *d*. at Bothwell Castle, on 13 February 1780,⁷³ aged 28 years), and secondly, on 13 May 1783, to Frances, daughter of Francis Scott, Earl of Dalkeith, and sister of Henry Scott, 3rd Duke of Buccleuch. He *d*. at Bothwell Castle, on 26 December 1827⁷⁴ and was father of:
 - 3a} Archibald Douglas, 2nd Lord Douglas, *b.* on 25 March 1773 and was served heir general to his father on 16 February 1828.⁷⁵ He *d.* unmarried, at Bothwell Castle, on 27 January 1844.⁷⁶
 - 3a} Charles Douglas, 3rd Lord Douglas, *b.* on 26 October 1775 and was served heir to his brother, Archibald, in the Dukedom of Douglas on 12 July 1844.⁷⁷ He *d.* unmarried, at St. George's Place, Hyde Park, on 10 September 1848,⁷⁸ and was succeeded by his brother, James.
 - 3a} William Douglas, b. on 31 October 1777 and d. young.
 - 3a} Jane Douglas, *b.* on 21 December 1779 and was served heir to her half-brother, Lord James Douglas, on 25 May 1857.⁷⁹ She *m.* at Dalkeith, on 22 November 1804, to Henry James Scott, Lord Montagu of Broughton, second son of Henry Scott, 3rd Duke of Buccleuch, and had issue.
 - 3a} Sholto Scott Douglas, b. on 17 September 1785 and d. without issue, at Tullamore, on 30 October 1821.⁸⁰
 - 3a} James Douglas, 4th Lord Douglas, *b.* on 9 July 1787 and succeeding his half-brother, Charles, he was served heir of entail to him on 11 January 1849.⁸¹ He *m.* at Beckley, Sussex, on 18 May 1813, to Wilhelmina, daughter of General James Murray,⁸² and *d.* without issue, at Bothwell

Castle, on 6 April 1857, 83 when the title became extinct. He was succeeded in his estate by his sister, Jane.

- 4. Sholto Stewart, was a twin with Archibald and was *b*. at St. Germain, on 10 July 1748. He *d*. at Edinburgh, in May of 1753.

He *m*. thirdly, at Edinburgh, on 12 September 1761, to Helen, daughter of Alexander Murray, 4th Lord Elibank, ⁸⁹ (she survived him *d*. at Ormiston, on 29 December 1810, in her 94th year⁹⁰), by whom he had no apparent issue.

SIR JOHN STEWART, 14TH **OF GRANDTULLY,** was served heir to his uncle, George MacKenzie of Farnese, on 16 August 1748, and to his uncle, Sir George Stewart, in the lands of Grandtully, Murthly, Strathbraan and others, on 30 September 1765.⁹¹

- 6. Clementina Stewart, *m*. firstly, at Murthly, on 6 November 1782, to Alexander Moray, 14th of Abercairney, ⁹⁸ (he *dsp* at Abercairney, on Friday 16 April 1784⁹⁹), and secondly, in 1786, to George Seton, son of James Seton, Governor of the Island of St. Vincent. ¹⁰⁰

SIR GEORGE STEWART, 15TH **OF GRANDTULLY,** *b.* at Ballechin, on 17 October 1750 and succeeded his father in 1797. He *m.* at Edinburgh, on 16 April, 1792, Catherine, eldest daughter and heir of John

He *m.* at Donibristle Park, on 19 January 1832, to Jane, eldest daughter of Francis Stewart, Earl of Moray, ¹⁰⁴ (she survived him and *m.* secondly, on 24 August 1839, to Lonsdale Pouden M.D.; and *d.* on 14 March 1880), and *dsp* at Paris, on 20 May 1838, having been of a weak constitution for some years. ¹⁰⁵
- 2. **SIR WILLIAM DRUMMOND STEWART, 17**TH **OF GRANDTULLY,** *b.* at Murthly, on 26 December 1795 and succeeding his brother, Sir John, he was served heir to him in the lands of Grandtully, and others, on 7 May 1839. He sold the lands of Logicalmond to the Earl of Mansfield in 1842 and also disposed of a good deal of his other properties. On his death, which occurred on 28 April 1871, 107 rumours circulated of his having been poisoned. This resulted in two autopsies being conducted and a temporary burial instructed before matters were settled and he was finally permanently laid to rest. He *m.* in May of 1830, to Christian Stewart, (she *d.* at Grandtully Castle, on 1 October 1856¹⁰⁸), and was father of,
 - 2a} William George Drummond Stewart, younger of Grandtully, *b.* in February of 1831 and *dsp vita patris*, at Hythe, on Monday 19 October 1868.¹⁰⁹
- 3. George Drummond Stewart of Braco Castle, *b.* at Murthly, on 3 November 1798 and to whom his maternal aunt, Frances Maria Drummond, conveyed her lands of Braco in 1845. He *dsp* at Braco Castle, on 3 June 1847.¹¹⁰
- 4. Thomas Stewart, b. at Murthly, on 21 December 1802 and dsp at Ancona, Italy, on 18 July 1846. 111

- 5. **SIR ARCHIBALD DOUGLAS STEWART, 18**TH **OF GRANDTULLY,** *b.* at Newington House, Edinburgh, on 29 August 1807 and succeeded his brother, Sir William, in April of 1871. He *m.* at St. Mary's Bryanston Square, London, on 4 May 1875, to Hesther Mary, eldest daughter of John Fraser of Bunchrew, 112 (she survived him and *d.* at Grandtully Castle, on 6 October 1916¹¹³), and *dsp* at Murthly Castle, on 20 September 1890, 114 when he was succeeded by Walter T. G. Fothringham of Powrie as heir of entail.
- 6. Catherine Stewart, b. on 26 August 1797 and m. in 1833, to Monsieur Des Ondes.
- 7. Clementina Stewart, b. on 9 September 1800 and d. unmarried, at Murthly Castle, on 19 September 1827.¹¹⁵
