ROLLO of DUNCRUB

JOHN ROLLO, 1ST **OF DUNCRUB,** is the first for whom there evidence but of his parentage and ancestry, nothing of any certainty can be said. He received payments from the exchequer in 1369 and 1370 for services to the king.¹ Then, commencing in 1371, he received further payments of £10 to be paid to him annually from the king's coffers² *quousque sibi provisum fuerit de decem libratis terre hereditarie,*³ or, "until he is provided with lands in heritage worth £10." He continued to receive those payments in 1373, 1374, 1375, 1377 and 1379,⁴ and was secretary to David, Earl of Strathearn, by 1380,⁵ from whom he acquired the lands of Findony, Duncrub and Ladcathy, near Dunning in lower Strathearn, by charter dated 13 February 1380/81.⁶ He received payments for his good services in 1388⁷ and a further payment of his annuity of £10 in 1389,⁸ and died in 1390. He had issue,

DUNCAN ROLLO, 2ND **OF DUNCRUB**, is styled heir apparent of his father in the charter by David, Earl of Strathearn, for the lands of Duncrub on 13 February 1380/81. He is styled son of the late John Rollo in 1390, when in reward for his hard work and diligence in exercising the office of clerk of the coquet of Edinburgh, the king granted him a penny from each sack of wool. He was included in a safe conduct by Richard II of England issued on 20 June 1394 "to come and go between

England and Scotland for a year. If the truce last that long."¹⁰ He had a further safe conduct on 29 March 1396 allowing him to travel "with ten servants on horseback, to pass through England and ship at any port they please for abroad"¹¹ and was appointed auditor of the crown accounts in 1410,¹² which he held up to the time of his death, which occurred in 1419-20.¹³ He was father of:

- 1. Andrew Rollo, 3rd of Duncrub, (see below).
- 2. Robert Rollo of Bello, had been admitted a burgess of Dundee by 31 December 1443 when he had a charter for a stretch of land in the Market Street of that city. He acquired the quarter-part lands on Petty from Walter Stewart of Cluny, on 24 December 1466, followed by a quarter of Pitpontie on 29 May 1468 and then those of Bello from Thomas Ogilvy of Clova by charter dated 22 October 1470. He died between 16 December 1480 and 22 February 1480/81, and had issue (see Rollo of Bello).

ANDREW ROLLO, 3RD OF DUNCRUB, was present at the retour of Agnes Menteith as heir to her brother, Patrick Menteith, in the lands of Thom, Rusky and others, on 28 April 1456¹⁸ and was in possession of the lands of Ardchailzie in 1466 & 1467,¹⁹ for which he a charter under the Great Seal in 1480. He granted a Bond of Manrent for the duration of his life to Laurence, 1st Lord Oliphant, on 21 April 1471,²⁰ and was bailie to a charter for the lands of Stix in favour of William Aysoun, son and

heir to Robert Aysoun of Fornocht, on 12 May 1472.²¹ He died after then and by 5 July 1481, and was father of:

- 1. Robert Rollo, fiar of Duncrub, (see below).
- 2. David Rollo, was included in his father's Bond of Manrent to Laurence, 1st Lord Oliphant, on 21 April 1471 and was bailie to a Sasine for the third-part of the lands of Balbegie in favour of his nephew, William Rollo, dated 5 July 1481, being then styled "in Findowy."²²

ROBERT ROLLO, FIAR OF DUNCRUB, was included in his father's Bond of Manrent to Laurence, 1st Lord Oliphant, on 21 April 1471. He died *v.p.* shortly after then and in the last days April 1471 leaving issue:

WILLIAM ROLLO, 4TH OF DUNCRUB, succeeded his grandfather, Andrew Rollo of Duncrub, and was infeft in the third-part of the lands of Balbegie as heir to him on 5 July 1481.²³ He had the lands of Duncrub erected into a free barony by James IV. on 26 August 1511,²⁴ for which he had Sasine in 1512,²⁵ and was killed at the battle of Flodden on 9 September 1513. His wife is said to have been a daughter of Sir Humphrey Moray of Abercairney but there is no evidence for her. He was father of:

- 1. Robert Rollo, younger of Duncrub, (see below).
- 2. Humphrey Rollo, was a member of the inquest at the retour of William Moray, as son and heir of the late William Moray of Castleton, on 9 May 1516, and had acquired the lands of Findowy before 6 March 1542. He was a sheriff depute to William, Lord Ruthven, sheriff of Perth, in an action raised by Henry Stewart, Lord Methven, against George Gorthy of that Ilk on 27 November 1546. He

married by 25 December 1541, to Janet Graham²⁶ with whom, on 2 February 1551-52, he had a gift of the ward and nonentries of the third-part of the lands of Balbegy.²⁷

3. A daughter, married Walter Drummond, 2nd of Balloch,²⁸ (he was killed at the battle of Flodden in September 1513) and had issue.

ROBERT ROLLO, YOUNGER OF DUNCRUB, is styled heir apparent to his father in a charter by William Aysoun of Fornocht granting the lands of Fornocht to John, 1st Lord Drummond, on 21 August 1504.²⁹ He married Janet Graham, said to have been daughter of William, 1st Lord Graham, with whom, on his father's resignation, he was infeft in the third-part of the lands of Balbegie on 15 August 1501,³⁰ and was killed with his father at Flodden on 9 September 1513. He had issue,

- 1. Andrew Rollo, 5th of Duncrub, (see below).
- William Rollo, is styled uncle to George Rollo of Duncrub when witness to a charter to that person for the third-part of the lands of Petamdie on 18 March 1574.³¹
- 3. David Rollo, 1st of Kincledie and Powhouse, became a notary public and acquired the lands of Powhouse, or Powis, near Stirling, on 4 June 1556. He married Marjory Livingstone and died on 14 March 1578 having had issue, (see Rollo of Powis and Rollo of Woodside).
- 4. Beatrix Rollo, married Oliver Sinclair of Pitcairns, with whom she had a charter for the lands of Allangrange from Mr William Sinclair, rector of Olrick, on 4 August 1564.³² They had issue.

ANDREW ROLLO, 5TH OF DUNCRUB, succeeded his grandfather and had Sasine for the lands of Duncrub as heir to him on 28 October 1513.³³ He married Marion, daughter and heiress of David Rollo of Bello, with whom he had a conjunct charter under the Great Seal for the lands of Bello and Duncrub on 21 May 1540, to themselves in liferent and their eldest son and apparent heir, George, in fee,³⁴ and died in March 1566.³⁵ He was father of:

- 1. **GEORGE ROLLO, 6TH OF DUNCRUB,** was infeft in the third-part of the lands of Balbegie as heir to his grandfather, Robert Rollo, on 1 February 1566-67.³⁶ He was served heir to his father in the lands of Innerdunning on 1 November 1573³⁷ in which he was infeft on 12 March 1573-4. He married Isobella, daughter of Sir William Moncrieff of that Ilk (marriage contract at Perth, on 26 November 1549³⁸) and died *s.p.* on 6 May 1581.
- 2. James Rollo, 7th of Duncrub, (see below).
- 3. Sir Walter Rollo of Lawton, was provided by his brother James Rollo, fiar of Duncrub, to the lands of Thaynesland on 4 April 1574³⁹ and was tutor to his nephew, Andrew Rollo of Duncrub, during his minority. He acquired rights to various lands including those of Gardyne which were confirmed to him by charter under the Great Seal on 19 September 1601.⁴⁰ He was twice married but the identity of his first wife has not been discovered. He married secondly, married to Jean, daughter of James Stewart, 5th Lord Innermeath, (marriage contract 10 October 1591.⁴¹ She survived him and married secondly, in February

1608, to Sir Alexander Jardine of Applegirth) and died on 27 May 1603⁴² having had issue by both wives,

- 3a} Andrew Rollo of Garden, succeeded his father and was served heir to him in the lands of Garden on 14 January 1604.⁴³ He disponed those lands to Sir Robert Crichton of Cluny on 21 March 1607 and died *s.p.* by 5 August 1635 when his brother, Peter, was served heir general to their father.
- 3a} George Rollo, against whom an arrest warrant was issued by the Privy Council on 30 May 1605 "for a civill debt."⁴⁴
- 3a} Peter Rollo, was served heir general to his father on 5 August 1635.⁴⁵ He served as a Captain in the army and was charged with the burning of the Frendraught castle. He married Mary, daughter and coheiress of John Stewart, 5th Earl of Atholl, (she was widow of James Stewart, 2nd Earl of Atholl) and died *s.p.* before 26 December 1657, whem his brother, Mr. John Rollo of Pilton, is styled his brother and heir.⁴⁶
- 3a} John Rollo of Pitmeadie and Piltoun, was trained to the legal profession and passed as an advocate on 6 January 1608, and appointed Commissary of Dunblane. He married at Edinburgh, on 8 January 1607, to Christian, daughter of William Justice, Merchant Burgess of Edinburgh, 47 (marriage contract 12 December 1606⁴⁸) with whom he had a conjunct charter for the lands of King's Powis alias Manner on 29 August 1616, following acquisition from Robert Callander of Manner, 49 and was father of,
 - 3b} Peter Rollo of Piltoun, baptised at Edinburgh, on 30 June 1614, and succeeded his father in the lands of Pilton. He died in 1653⁵⁰ having

married firstly, by 28 November 1635, to Elspeth, youngest daughter of James Haliburton, merchant Burgess of Edinburgh.⁵¹ Surviving her, he married secondly, to Marie, only child of Alexander Stirling of Powhouse, (she survived him and married secondly, on 16 March 1654, to Mr. John Justice,⁵² and thirdly, by 11 July 1663, to George Cockburn of Pilton⁵³) and was father of:

- 3c} John Rollo, baptised at Edinburgh, on 25 May 1637 and died young.
- 3c} Patrick Rollo, baptised at Edinburgh, on 6 March 1653 and died young.
- 3c} Anna Rollo, baptised at Edinburgh, on 16 November 1638 and died young.
- 3c} Christian Rollo, was a daughter by her father's first marriage.
- 3c} Sarah Rollo, both of whom had a Bond registered on 3 October 1683 in which they are styled daughters of Peter Rollo of Piltoun.⁵⁴
- 3b} John Rollo of Piltoun, is styled brother and heir to the deceased Peter Rollo of Pilton in a precept for the lands of Balinblair and Moneydie in favour of John Graham, fiar of Balgowan, on 27 December 1656,⁵⁵ and had the lands of Piltoun apprised from him by his creditors on 27 July 1654.
- 3b} Walter Rollo, baptised at Edinburgh, on 28 December 1627 and graduated from the University of Edinburgh on 15 April 1645.
- 3b} Thomas Rollo,⁵⁶

- 3b} Christian Rollo, baptised at Edinburgh, on 21 August 1608 and died young.
- 3b} Marion Rollo, baptised at Edinburgh, on 18 October 1612.
- 3b} Catherine Rollo, baptised at Edinburgh, on 17 September 1615.
- 3b} Christian Rollo, baptised at Edinburgh, on 1 December 1616.
- 3a} Elspeth Rollo,
- 3a} Christian Rollo,
- 4. William Rollo, 1st of Balbegie, acquired the lands of Balbegie and had a gift under the Privy Seal of the Chaplainry of St. Salvador in Our Lady's Church of Dundee on 5 December 1588.⁵⁷ He appears to have been twice married. The identity of his first wife has not been discovered but he had issue by her. He married, secondly, after 12 August 1592,⁵⁸ to Elizabeth, daughter of Peter Hay of Megginch, (she was widow of Gilbert Gray of Bandirran, brother of Patrick, 6th Lord Gray, whom she had married by marriage contract dated 18 April 1587.⁵⁹ She died on 1 April 1600⁶⁰) and died before 16 June 1612. He was father of,
 - 4a} James Rollo, 2nd of Balbegie, is styled eldest son to William Rollok of Balbegie in an undertaking given by he and his father on 1 April 1608, to dispone their tenement and yard in Dundee to Dr. David Kinloch.⁶¹ He married by 22 November 1610, to Euphemia Ramsay, (she survived him and disponed their lands of Camiston to Patrick maule of Panmure in 1633⁶²) when they acquired the half-part of the lands of Wormet from John Bruce,⁶³ and is mentioned in a charter concerning Ludovick Crichton of Nauchtan in May 1621. He died before 1633 and was father of,

- 4b} James Rollo of Monkisholme, is styled eldest son of the late James Rollok of Balbegie when he renounced his rights to the lands of Camistoun Mill on 20 January 1636.⁶⁴ He married Margaret, daughter of William Goldman, bailie of Dundee, who survived him and as his relict, she granted discharge on 20 June 1667, to Mr. James Davidson.⁶⁵ He had issue,
 - 4c} Andrew Rollo, baptised at Dundee, on 19 May 1646 and on whose behalf his mother granted discharge to Mr. James Davidson on 20 June 1667.⁶⁶
 - 4c} Janet Rollo, to whom her grandparents William Goldman, bailie of Dundee, and Janet Guthrie assigned 2000 merks on 23 December 1643.⁶⁷
- 4b} Isabel Rollo, is named with her brother James in discharges by their mother relating to the lands of mill of Camiston in 1633.⁶⁸
- 4b} Eupham Rollo, married Andrew Rollo, eldest son of Charles Rollo, burgess of Perth.
- 4a} George Rollo, was provided by his father to the chaplainry of St. Salvador in Dundee on 13 October 1599.⁶⁹ He consented to his father assigning their tack of the teinds of the lands of Bello to Sir Andrew Rollo of Duncrub on 2 March 1609.⁷⁰
- 4a} Robert Rollo, became a burgess in Dundee.
- 4a} Janet Rollo, brought a complaint against Peter Hay of Kirkland on 10 December 1612, for having rmeained unrelaxed from a horning obtained by her on 16th June previous for none-payment of 1900 merks and 500

merks expenses, and is then styled daughter of the late William Rollo of Balbegie.⁷¹

- 4a} Isobel Rollo, married George Hay, fourth son of Dr. Peter Hay of Kirkland Rattray, (marriage contract 17 February 1618⁷²) and had issue.
- 5. Andrew Rollo, acquired the lands of Corstoun and was a witness to a charter by John Crichton of Strathurd for an annualrent of 100 merks in favour of James Dykis, Merchant Burgess of Perth, on 28 May 1610, in which he is styled brother to Sir Walter Rollo of Garden.⁷³ He was witness to a charter for the lands of Clevadge in favour of James Mercer, son and heir of Laurence Mercer of Clevadge, on 26 July 1611, and is then styled lawful son of the deceased Andrew Rollo of Duncrub.⁷⁴
- 6. Dr. Peter Rollo of Pilton, is named with his brothers, James Rollo of Duncrub, Walter, Andrew, William and Humphrey in a contract dated May of 1581,⁷⁵ and had been consecrated Bishop of Dunkeld by 16 March 1585 when he disponed certain lands to Robert Boyd in Dunkeld by charter of that date. He married firstly, by 20 July 1596, to Christian, sister of Captain David Cant,⁷⁶ (she was widow of Colonel Henry Balfour⁷⁷ by whom she had issue) and secondly, to Elizabeth Weston, who as relict of John Fairlie, portioner of Restalrig, and now wife to Mr Petir Rollok of Piltoun, one of ytje senators of the College of Justice, she brought a complaint against Matthew Fnlayson of Killeith on 15 November 1610.⁷⁸ He died in 1631x32 and was father of,
 - 6a} Walter Rollo, a natural son.

- 7. Marjorie Rollo, married firstly, to George Graham, 2nd of Inchbraikie, (he died in 1575) and secondly by 4 April 1584, to John Graham, 1st of Balgowan. She is styled wife of John Graham of Balgowan and Lady Inchbraikie in a charter to them for the lands of Newraw dated 29 August 1586,⁷⁹ and died on 24 February 1625.⁸⁰ She had issue by both husbands.
- 8. Mary Rollo, married Laurence Oliphant, 3rd of Newton and Thrumster, and had issue.
- 9. Janet Rollo, who was offered in marriage to John Callander, grandson and heir of Robert Callander of Maner, on 20 March 1555.
- 10. Marion Rollo, married firstly, to John Stewart of Calziebrochan and was included with him and his parents in a liferent to them for the lands of Durdie-Inglis on 12 December 1568.⁸¹ Surviving him, she married secondly, to Andrew Blair, 1st of Rossie Ochill, third son of Alexander Blair of Balthayock, (marriage contract 26 December 1574⁸²) and had issue.
- 11. Isobel Rollo, married David Cochrane, eldest son and heir of Patrick Cochrane of Pitfour, (marriage contract 17 September 1576⁸³).
- 12. Katherine Rollo, married in October 1563, to Alexander Balmanno of that Ilk though the marriage was not a happy one and she became compelled to seek a process of adherence against him on 28 June 1570.⁸⁴
- 13. Margaret Rollo, married William Drummond of Belliclone and is included with him in a charter to them by James, Commondator of Inchaffray, for the lands of Ardewny on 31 January 1585.85

He was also father of two natural sons:

- 14. Humphrey Rollo, was a natural child and is styled natural brother to Wa;ter Rollock, tutor of Duncrub, when witness toa Sasine in favour of Adam Menzies for the lands of Stroncomrie and others, dated 25 November 1588.⁸⁶ He received letters of legitimation under the Great Seal on 14 January 1589⁸⁷ and settled at the mill of Findony. He married Christian Chalmer, (she survived him and married secondly, in late 1601 to Adam Hepburn, 2nd of Bonhard⁸⁸) and died on 12 June 1601, while in France.⁸⁹ He was father of,
 - 14a} Humphrey Rollo, is named in his father's Testament in 1601.
- 15. Charles Rollo, was a witness to a charter by Mr. David McGill, Advocate, granting the lands of Haugh of Fungorth to Henry Greig 15 July 1585, to which Peter Rollo, Bishop of Dunkeld, gave his consent and to whom he is styled a natural brother. He became a Burgess of Perth and was charged by the Privy Council in 1619 for dealing in illegal tobacco. He granted a Discharge, in the capacity of factor to Alexander Lindsay, Bishop of Dunkeld, for certain teinds in Perth on 5 November 1631. He married Janet, daughter of Alexander Pennicuik of Stenton, (she was widow of Mr. John Lawrie, Burgess of Perth⁹¹) with whom he was infeft in an annualrent of four hundred merks ffrom the lands of Strathie-Chalmer by John, Earl of Montrose, on 13 May 1619. He died by 17 September 1636 having had issue;
 - 15a} Andrew Rollo, was served heir to his father in the lands of Pitmurthly on 17 September 1636.⁹³ He married by 10 May 1635, to Eupham, daughter of James Rollo of Balbegie.

- 15a} Mr. Alexander Rollo, baptised at Perth, on 28 February 1615, and witnessed a Discharge by his father on 5 November 1631. He was admitted minister of the West Church in Perth. He married Marjory, daughter of James Stewart, 1st of Ladywell, and died on 17 October 1652 having had issue;
 - 15b} Charles Rollo, who died s.p. in 1666.⁹⁴
 - 15b} James Rollo, who died s.p. in 1666.95
 - 15b} Alexander Rollo, baptised at Perth, on 23 October 1648. He and his brother, Robert Rollo, were joint executors to their brothers Charles and James Rollo in 1666.
 - 15b} Robert Rollo, born on 19 September 1652 and became a merchant in Perth.
- 15a} Henry Rollo, became a merchant and Baillie in Perth. He married Elspeth Gall and was father of,
 - 15b} Charles Rollo, baptise at Perth, on 30 April 1638.
 - 15b} Thomas Rollo, baptised at Perth, on 23 April 1642.
 - 15b} John Rollo, baptised at Perth, on 26 August 1644.
 - 15b} James Rollo, became a Saddler in Perth and is styled son of the deceased Henry Rollo, late Baillie, when appointed curator to his late brother George's children as next-of-kin on the father's side on 31 May 1687.⁹⁶
 - 15b} George Rollo, became a flesher and Burgess of Perth. He married Margaret, sister of David Ireland, Doctor of the Grammar School of Perth, 97 and died before May 1687. He was father of, 15c} George Rollo, baptised at Perth, on 27 September 1663 and died young.

- 15c} George Rollo, baptised at Perth, on 10 August 1676 and being a minor at his father's death, he and his sisters Janet and Marjory, had their paternal uncle James Rollo, saddler, son of the late Henry Rollo, late Baillie of Perth, adjudged to be nearest agnate to them on their father's side on 31 May 1687. He was served heir to his father on 14 January 1686 and is then styled his only son.
- 15c} John Rollo, baptised at Perth, on 6 February 1665 and died young.

Cluny, whom he had married in 1586,¹⁰² and by whom he had issue) and is included with him a charter to James Dickson, portioner of Wester Banchrie for the lands of Wester banchrie dated 23 and 28 May 1603.¹⁰³ they had issue

4. Marion Rollo, married Sir James Bruce of Powfoulis (marriage contract 1 January 1608) and died on 24 December 1642¹⁰⁴ having had issue.

SIR ANDREW ROLLO, 8TH OF DUNCRUB AND 1ST LORD ROLLO, was born in 1577 and succeeding his father, he was infeft in the lands of Duncrub, Bello and others, as heir to him on 29 January 1598-9.¹⁰⁵ He was infeft in the third-part of the lands of Balbegie as heir to his great-grandfather, Robert Rollo, on 22 October 1638,¹⁰⁶ and was raised to the Peerage as Lord Rollo on 10 January 1651.

He married Katherine, daughter of James Drummond, 1st Lord Madderty, and died on 22 May 1669 having had issue,

- 1. James Rollo, 2nd Lord Rollo, (see below).

- 4. Andrew Rollo, born in March 1605, and was trained for the church. He was admitted Minister at Dunning and is so-styled in a charter to him for the lands of Mill of Findowny from his brother James, Master of Rollo, on 25 June 1653.¹⁰⁸

- 4a} David Rollo, baptised on 10 February 1645 and was apprenticed to Mungo Wood, Merchant in Edinburgh, on 9 September 1665¹¹² then admitted to Burgess there on 22 September 1697.¹¹³ He was served heir to his father in the Grain Mill of Findowny on 12 December 1673,¹¹⁴ then to his brother, Andrew Rollo, and heir portioner of his grandfather, John Lindsay of Dunkenny, in a fifth-part of the lands of Kirkton of Essie in 1671.¹¹⁵ He married on 15 September 1668, to Bethia, daughter of Rev. Robert Lawrie, Bishop of Brechin,¹¹⁶ (she was buried in the Greyfriars, Edinburgh, on 13 January 1693¹¹⁷) and was buried in the Greyfriars, Edinburgh, on 1 April 1724.¹¹⁸ He was father of,

- 4b} Archibald Rollo, baptised at Edinburgh, on 5 December 1679.

- 6. Margaret Rollo, born on 10 January 1610 and married Sir John Drummond of Carnock. As his wife, she consented to his resignation of the lands of Carnock to Mr. Thomas Nicolson, Advocate, in 1634, 125 then to the disponing of those of Bannockburn to her brother John Rollo and Isobel Cockburn, his wife, in 1636. 126 They had issue.
- 7. Jean Rollo, born on 13 February 1615 and married firstly, to Robert Rollo of Powis, (marriage contract 30 September 1652¹²⁷) by whom she had issue. She married secondly, by 4 April 1671, to John Drummond of Pitkellony, ¹²⁸ (he was widow of Catherine, daughter of Sir John Colquhoun of Luss) and had further issue.

JAMES ROLLO, 2ND **LORD ROLLO**, born on 11 December 1600 and succeeded his father in 1669. He married at Edinburgh, on 24 April 1628, to Dorothea, daughter of John Graham, 4th Earl of Montrose, ¹³¹ (she died on 16 May 1638, and was buried at Holyrood ¹³²) by whom he had no issue. He married secondly, to Mary, daughter of Archibald Campbell, 7th Earl of Argyll, (marriage contract dated in March

1642¹³³) and was active in his support of his second father-in-law the Marquis of Argyll and was aboard his galley in 1644 when the armies of Argyll and Montrose met at Inverlochy. He died at Duncrub, on 12 June 1679¹³⁴ and was father of:

- 1. Andrew Rollo, 3rd Lord Rollo, (see below).
- 2. Archibald Rollo, served as a Captain, then Major in the army and was cautioner to his sister, Margaret, in her marriage contract with George Oliphant in 1682.

ANDREW ROLLO, 3RD LORD ROLLO, baptised at Tillicoultry, on 12 July 1646 and succeeded his father in 1679. He married in November 1670, to Margaret, daughter of John, 3rd Lord Balfour of Burleigh, ¹³⁷ (she survived him and died at the Canongate, Edinburgh, on Tuesday 20 October 1734, in her eighty-second year. ¹³⁸ She brought an action against her husband on 14 January 1696 for having deserted her and gone abroad with his mistress, Isobel Kinninmond). He died on 4 March 1701 and was father of,

1. John Rollo, Master of Rollo, the eldest son, was killed by Patrick Graham, fiar of Inchbraikie, on 20 May 1695. The reasons for this make interesting reading as he was fatally wounded by the sword of James Edmonstone of Newton. All three had been dining at the house of David Drummond of Innermay and on their way home an argument ensued between he and Graham. After a short scuffle he was

left on the ground mortally wounded and supported by Mercer of Clevadge who cried out "never a more horrid murder had been seen" to which Edmonstone replied "I think not; I think it was fairly done." Edmonstone was found guilty of complicity and sentenced to banishment for life with Graham being outlawed and forced to flee the country for some years.

- 2. Robert Rollo, 4th Lord Rollo, (see below).
- 3. David Rollo, born in July 1689 and was buried in the Greyfriars, Edinburgh, on 4 February 1707. 139
- 4. Emilia Rollo, born on 4 July 1676 and married at Edinburgh, on 25 August 1698, to William Irvine of Bonshaw¹⁴⁰ She died at Bonshaw, on Friday 20 March 1747¹⁴¹ having had issue.
- 5. Isabel Rollo, married Robert Johnston of Wamphray, (he died on 28 October 1733¹⁴²) from whom, on 7 August 1703, she had a liferent provision in implementation of their marriage.¹⁴³ She survived her husband and died in January 1742¹⁴⁴ having had issue.
- 6. Susan Rollo, married on 1 May 1710, to Hugh Gillespie, Ireland, and had issue.

ROBERT ROLLO, 4TH LORD ROLLO, born on 12 June 1679 and succeeded his father in 1701. Although he supported the Treaty of Union in 1707, he was active in the Jacobite rising of 1715 and following its failure he and the Marquis of Huntly surrendered themselves to Brigadier General Grant at Inverness in March 1716.¹⁴⁶

He was held in Edinburgh castle until August 1717 when he received royal pardon and released.¹⁴⁷

- 2. Henry Rollo, born at Blackness Castle, on 12 June 1705 and acquired the lands of Dalreoch and Balgowers for which he had a charter under the Great Seal on 18 February 1740.¹⁵⁷ He married on 25 July 1724, to Anne, sister of James, 3rd Lord Ruthven, and died *s.p.* at London, on 2 July 1745.¹⁵⁹
- 3. John Rollo, 6th Lord Rollo, (see below).
